# MISSING IN NEVADA

On Tue 19 November 2019, 17 Forgotten Veterans were laid to rest at the Southern Nevada Veterans Memorial Cemetery (SNVMC). This was the third group of Missing in Nevada Veterans to be honored. Forty-nine Forgotten Veterans were interned previously June and October 2018.

These are Veterans who have passed, and no one came to claim them, one of the Veterans served in WW I and died in 1995. Lynda Freeman from the Nevada Veterans Coalition is the researcher that goes to the Mortuaries to review their records for unclaimed individuals to find the Veterans.

Several local Veterans organizations participated in this event.

The remains were escorted from the Desert Memorial Cremation & Burial by the Nevada Highway Patrol and the Southern Nevada Patriot Guard Riders. Upon arrival at the SNVMC the remains were brought into the chapel by Honor Guard members from the NV Army National Guard, Air Force members from Nellis, US Navy and a Marine.

Bobi Oates, SMSgt, USAF, Ret was the emcee for the service and also read the 13 Flag folds while the NVANG did a 6 person flag fold.

Capt. Troy Dandrea, Chaplain, NVARNG gave the Invocation and Benediction.

Emil "Buck" Bedard, Lt Gen, USMC, Retired was the guest speaker He reminded us all to talk with our older Veterans to check in on them, see how their day is going and their general well-being, to be a good neighbor. No more Veterans should be forgotten or lost only to be remembered 40 -50 years later. He finished by reading

The Disabled Veterans Black Mountain Chapter 12 rendered a 21-gun salute followed by TAPS preformed by Trumpeters Alliance to Perform Patriotic Services.

The Scottish American Post 711 bagpipers lead the procession to the grave site, playing Amazing Grace. Chaplin Danny McDonald, SAMS 711 read the 23<sup>rd</sup> Psalm and as the Honor Guard members laid the Veterans to rest Cynthia Mann played military tunes on her flute.

# MESSAGE FROM THE 1<sup>st</sup> VICE COMMANDER

Greetings All!! I wanted to take a minute to let you all know about an exciting new program.

Effective January 1st, 2020, Veterans with a service connected disability will be authorized to shop at the base commissary. If your service connected disability is from 0-90 %, and it shows "Service Connected" on your card, You're in.

In a recent article on the "Military Times" website, they state that base access will be granted by placing your VA medical ID card in a scanner, and it will approve your entry. You are permitted to bring a guest with you, but if the guest does not have previous access, you will be required to stop by the visitors center and get the appropriate visitors badge.



This opens the Commissary to approximately 3 million more Veterans. Additionally, certain welfare and rec benefits will also be included in this program, and those will be rolled out over time.

Last year, Veterans who previously had no access to the PX or Navy Exchange web sites, were permitted to enroll and be able to shop online. The enrollment process is very easy, and I highly recommend all Legionnaires make use of this cost saving benefit.

As Always, It's great to see so many of you at the meetings, and I look forward to seeing all of you in 2020.

# VA RESIDENTIAL RECOVERY AND RENEWAL CENTER

VA's Southern Nevada Healthcare System is proud to announce the grand opening of the Las Vegas VA Residential Recovery and Renewal Center (LVR3). It's only the second residential gambling addiction recovery center in the nation.

LVR3 is a 30- to 45-day substance use and gambling residential treatment program. It is a 20-bed facility, with a separate wing with five rooms for female Veterans. The center provides research-based, high quality interventions to help residents:

- ♦ Help learn about addiction and triggers and developing a sustainable relapse-prevention plan.
- Develop individualized and person-centered recovery plans.
- Provide a whole health approach to help improve emotional, physical and mental health.
- Assist residents choose, access and use community and social supports.

This is the VA's first residential program in Southern Nevada. As a result, "there is definitely a great need for this here in Las Vegas," said LVR3 Program Manager Roxanne Untal.

"Gambling and substance abuse already exist here. It's important that we are responsive to that when problems arise for our Veterans. The biggest goal is to provide residential care for Veterans when more intensive care is needed than what they would receive in outpatient treatment."

Dr. Roxanne Untal gives a tour of the LVR3 to airmen from the Michael O'Callaghan Military Medical Center at Nellis Air Force Base.

"This facility fills a gap in our mental health continuum of care," said Tim Jobin, chief of Behavioral Health. "The staff has dedicated countless hours of planning, mindfulness and reviews to make this happen here today. This is a great day for Veterans."

Treatment at LVR3 includes daily activities. Recreational therapists provide instruction in exercises like archery, horse-back riding and yoga.

LVR3 also provides a staff attendant who is available 24/7.

Veterans interested in a referral for the LVR3 can talk to their primary care provider or can take advantage of the sameday mental health service.

"One of the biggest services we offer is the same-day walk-in service for mental health care," said Dr. Untal.

"Even if you aren't an enrolled Veteran yet, if this is something you need to address, come on in. Any licensed provider can put in a consult, and we are doing quick turn-around for screening them for admission."

# **Geocaching Merit Badge**

During the Boy Scouts of America's Las Vegas Area Council's Grand Camporee, October 11th - 12th event Legionnaire Steve Bickford taught a class for those scouts desiring to earn their Geocaching merit badge.



On Sunday morning nine scouts (and one parent) showed up for the merit badge class. The first two hours were devoted in going over the seven of the nine requirements for the badge, such as learning about Latitude and Longitude, what is GPS and GPS devices, caches - what are they, and of course safety out in the field. The last hour was optional and it had to do with going around the park looking for a hidden cache, placed and maintained by a member of Geocaching.Com. Four scouts wanted to go and with Garmin GPS devices in hand we went for a "Walk About." It took about ten minutes to get to the general area and another fifteen minutes for one of the scouts to find the cache. Next, I had previously hidden one of my own caches and once again we were on another "Walk About." About twenty minutes later another scout found it and we called it a day. After taking this class one scout was able to finish his remaining requirements to earn his Geocaching merit badge. The weather was perfect, the scouts had fun, and Legionnaire Bickford cannot wait to do it again next year.

### **Radio Merit Badge**

In preparation the Boy Scouts of America's "Jamboree on the Air" event October 19th, also known as JOTA. Legionnaire Steve Bickford (call sign N6AE) helped teach a class for those scouts desiring to earn their Radio merit badge. Both of the events, instruction and radio air time were held at the Las Vegas Area Council's main facility located off Paradise and 215.

On October 18th, Friday evening eight scouts showed up for the merit badge class. The four hour class was primarily a PowerPoint presentation with personal experiences tossed in covering the nine requirements for the badge, such as learning about frequency spectrum, amateur and commercial radio, how the ionosphere effects long distance contact, as well as electrical, lightening, and RF safety.

Then the next day, Saturday, October 19th was dedicated to "On the Air." Around fifteen scouts showed up to participate. This is where a scout tries to make contact with another scout using amateur radio. Questions were asked and answered regarding Troop Number, Scout Rank, Breakfast or Lunch, Patrol Name, and etc. Four radios were available for the scouts to use to make contact with one another. The Boy Scouts of America's JOTA is a yearly event that typically occurs every October. With the amateur air waves a buzz with JOTA "traffic" from around the world scouts were able to fulfill one of the requirements for the Radio merit badge:

"Using proper call signs, Q signals, and abbreviations, carry on a 10-minute real or simulated amateur radio contact..." "On the Air" start time was 9:00 a.m. and we finally called it a day at 2:30 p.m.

# American Radio Relay League's Annual "Field Day" Results for 2019 Published.

Back in mid-June two Legionnaires, Steve Bickford – N6AE and Pete Cervantes – KG7OKY, were at a remote location known only as the "Hestand Hide Away" somewhere North of Cave Lake Reservoir. It was here where they were on-the-air participating in ARRL's annual Field Day event. A twenty-four hour contest where you try to make as many radio contacts as possible. Each contact and other factors contributed to their overall score. Their Category/Section of "1B-Nevada" and sixty-one contacts gave them a combined score of 372 points.

Setting up a portable radio running on batteries, stretching out a long horizontal dipole antenna, and putting up with near freezing temperatures at an altitude over 7,600 feet they somehow managed to make sixty-one contacts ranging from Hawaii to the Eastern seaboard as well as up into Canada. They were the only ones to represent the Nevada section in their particular category.

We were located north of Cave Lake Reservoir, Nevada at an elevation just over 7,600 feet. Our antenna was a basic horizontal wire dipole using three Buddipole tripods and 18-foot masts for support. We experienced gusty winds from time to time and everything had to be three-point guyed.

In the late evening/early morning the temperature dropped to the low to mid 30s. The surrounding mountains over 8,500 feet were still snow-capped and help bracket a scenic 360-degree panoramic view of the area.



# January is Cervical Cancer Awareness Month.

VA encourages you to talk to your primary care provider about cervical cancer testing because early detection can help save your life. Cervical cancer was once the number one cause of cancer-related death in women. Due to increased screening, the number of cervical cancer deaths in the United States has dropped by more than 50% since the 1970s, according to the American Cancer Society.

Cervical cancer is one of the most treatable cancers if found early. A Pap (Papanicolaou) test, also known as a Pap smear, looks for cancer and pre-cancerous cervical cells. This test and screening for the human papillomavirus (HPV) testing, which is the cause of most cervical cancers, often leads to early detection. In addition to screening, there is a vaccination to prevent HPV. It is most effective if administered during childhood or adolescence, but adults can benefit from it, too.

Cervical cancer — These are some of the most helpful questions to ask during your next primary care visit:

How often do I need a Pap or HPV test, or both?

If my test is abnormal, how will I be contacted?

Should I receive the HPV vaccine?

Depending on your age and current cervical health, you can be screened in three- or five-year increments. VA and the United States Preventive Services Task Force (USPSTF) released new screening guidelines in 2018. You can connect with your primary care provider to better understand the new scheduled recommendations.

For women Veterans between the ages of 21 and 29, VA recommends a Pap test every three years.

For women Veterans between the ages of 30 and 65, VA recommends one of three options:

A Pap test every three years.

Both the Pap and HPV tests every five years.

An HPV test every five years.

Speak to your VA provider about how to schedule a cervical cancer screening, your Pap and/or HPV test at your local VA facility.

#### Here are answers to 11 key questions about the new L.E.G.I.O.N. Law and what it means for The American Legion.

Question: How does this change the eligibility requirements for The American Legion?

Answer: The only change is that Congress has reduced the number of eligibility periods from seven to two. They are April 6, 1917, to Nov. 11, 1918, and Dec. 7, 1941, and continuing. No other restrictions are changed.

Question: What's the impact on veterans who previously were not eligible for American Legion membership?

Answer: Veterans who were honorably discharged but whose service did not fall into the previous defined war eras may now join The American Legion immediately.

To do so, eligible members may sign up at www.legion.org/join.

Question: I am among the veterans who were not allowed to join previously, so why do you want me now?

Answer: The American Legion's founding fathers believed, "a veteran is a veteran," an axiom that has held true throughout the organization's more than century of service. Some veterans were ineligible to join because of the war eras that were defined by Congress. The recent bill passage and president's signature changed that.

Question: So how does this differentiate The American Legion from AMVETS?

Answer: The American Legion's eligibility criteria states that veterans must have served during "wartime." When Congress decides the U.S. is no longer in a state of war, the Legion's membership eligibility period will close, while AMVETS will still be open to those who served.

Question: How does this affect the Sons of The American Legion (SAL)?

Answer: The Sons' eligibility criteria will change along with that of The American Legion. Any son or grandson of a living American Legion member will be able to join the SAL program. (Sons and grandsons of deceased veterans are also eligible.) For example, a son of a veteran who served between 1985 and 1988 previously would not have been eligible.

With the extension of the war period, that veteran would immediately be eligible for The American Legion and the son would be able to join the SAL.

Question: How does this affect the eligibility for the American Legion Auxiliary?

Answer: This follows the same concept as the SAL, as noted previously. Membership in the American Legion Auxiliary is currently open to grandmothers, mothers, sisters, wives, and adopted female descendants of eligible veterans.

Question: How does this affect membership for departments, districts and posts?

Answer: This change opens up American Legion membership to millions more veterans who likely live in your communities. They may become members immediately.

Question: The current membership applications don't address the eligibility change. How do we process those members? Answer: New membership materials will be developed and provided as quickly as possible. Until then, it is recommended that prospective members from a previously undocumented war era write "Other Conflicts" in the eligibility date section and send it in to their department with the appropriate dues.

Question: What steps should departments, districts and posts focus on?

Answer: A good first step would be to review all recruiting materials to look for eligibility dates. Information on electronic media (websites, social media channels, etc.) should be changed immediately. It is up to departments to decide on the best way to handle printed materials, while updated ones are being produced.

Question: How does this change the Paid Up For Life program?

Answer: There are no changes to the PUFL program, though the newly eligible members would be able to become PUFLs. To learn more about the program, visit https://www.legion.org/PUFL.
