Invoices for the 2016 dues year will begin to be mailed about 1 July 2015 from The American Legion Headquarters. You can renew your Post 76 membership online (preferred method) at www.legion.org (have your

Member ID # ready), or you can mail a check for \$35 to American Legion Post 76, PO Box 34012, Las Vegas, NV 89133. If you renew your membership before 1 October, your Member ID card will be mailed with an Early Bird symbol stamped on it! You can help us save postage and worries if you renew your membership as soon as possible when the invoices begin to arrive in your mail boxes.

As the 2016 dues season moves on beyond 1 July, Legion members need to be alert for multiple dues invoice mailings from our Headquarters. There is an unavoidable time delay from when you renew your membership online or by mail and when you actually get your renewal logged at Headquarters; so you may receive another dues invoice, even though you know you've paid. All Legionnaires who have renewed their membership receive a Welcome Letter from the Post 76 Commander with their 2016 Member ID Card. This is your receipt for payment of dues, and you know you can ignore any subsequent dues invoices. If you have any questions about your membership status, you can call the Adjutant, Stephen Daugherty, at 253-691-0617 any time 24/7.

Post 76 has instituted a policy that every new member or transferee from another post must submit their service discharge papers (usually Form DD214) with an application. We also continue to ask present members to submit a copy of their DD214 to be on file in the event that we get an audit from the Internal Revenue Service (IRS). Many members have submitted copies, and we thank you for helping us stay ahead of the IRS. If you haven't already, please try to forward a copy of your discharge papers to Post 76 by (1) attaching it to an email and sending to NVPost76@gmail.com; (2) sending via USPS mail to: NV Post 76, P.O. Box 34012, Las Vegas, NV 89133-4012; or (3) bringing your document along to a meeting and hand deliver it to the Adjutant or any other officer. If you need to get a new copy, you can apply online at http:// www.archives.gov/veterans/ military-service-records/. It's a free service, so don't get involved with a 3rd party website and pay for the services.

If you have a question on whether or not you have forwarded a copy, please call the Adjutant, Stephen Daugherty, at 253-691-0617 for any assistance you need to move this important task along.


Welcome Home for Honor Flight Southern Nevada



Post 76 welcomed home WWII Veterans returning from their flight returning from Washington DC. This flight, for the first time included two wounded warriors who were not of WWII vintage, but one from Vietnam and one from the Global War on Terror. They were going to accompany WWII era relatives. As a special treat, Kris Kringle [Santa Claus] was there to greet them as well and present them with a special certificate

Nearly 70 years after World War II, veterans from Southern Nevada were sent on a weekend trip to Washington, D.C. to be honored at a special ceremony at the World War II Memorial. It was an honor for us to recognize them during their special "Mail Call." Post 76 generated over 250 letters to be given to them on the return flight. If added in those from Santa that were given to us to deliver, and those from District 2, we accounted for over 300 letters.

Over 16 million Americans served in WWII. More than 400,000 died in the war, and several million were wounded. The WWII Memorial was completed in 2004. Today, the average age of WWII veterans is over 85; more than 1000 pass away every day. Most WWII veterans have never visited their Memorial. We were very happy to help in our little way to allow them to be among the few who were able to stand there and recall the sacrifice they and their buddies gave so that to-

Welcome Home Bill Knapp from his Trip to Holland

Second Lieutenant William F. Knapp, a member of The American Legion Post 76 in Las Vegas, returned home from Holland on Friday May 8, 2015 from a trip to commemorate VEDay with other Allied veterans who participated in the fierce combat there. Legionnaire Knapp, a highly decorated WWII veteran, jumped as a paratrooper with the 82nd Airborne Division into Normandy on D-Day, 5 June 1944. He subsequently jumped into the Holland during Operation Market Garden offense to circumvent Germany's Siegfried Line. Legionnaire Knapp received a battlefield commission to Second Lieutenant and was awarded the Purple Heart and Bronze Star as well as a host of unit citations for his combat role. On his return at McCarran Airport, Post 76 VVA Chapter 17, and members of the Patriot Guard formed a flag line to welcome him home again. Memorial Day 2015



The 13th Annual Lakes Memorial Day Ceremony was held on May 25th, 2015 at 9:30 AM. The ceremony was sponsored by Post 76, and Post 14, with the assistance by other west and northwest Las Vegas American Legion Posts. Support was provided by The Lakes Association and seating was donated by Bright Angel Church of Christ and transportation of the chairs facilitated by providing a truck from Thomas Automotive. Many other Veteran related groups such as the Society of Military Widows, Gold Star Mothers, Gold Star Families, and the Gold Star wives are participating. Distinguished Guest Speakers included The Honorable Dr. Joseph Heck and Maj. Sean Fellows, Directorate of Intelligence, The Joint Chiefs of Staff, The Pentagon. The highlight of the ceremony was the passing of the wreath from the Gold Star representatives to veterans of

the war eras, and finally to JROTC Cadet Commanders who placed the wreath on the water from a boat.

No Veteran Alone

Each Thursday morning, members of Post 76 led by Commander Forman, make their way to the Veterans Memorial Cemetery in Boulder City to attend services for veterans being buried without family or friends to attend their funeral. Along with the Patriot Guard who stand flag lines along with many others from veterans organizations, and just grateful citizens, who give of their time to attend and honor those who served and are now entering the Post Everlasting.

"It just feels like the right thing to do. It's sad that they have nobody," said Bobi Oates, member of Post 76, and participating member of the Women Veterans of Nevada. "We have to take care of our veterans and give the example so that others will take care of us as we go along." The services are provided on alternating months by the Women Veterans of Nevada and the Vietnam Veterans of America Chapters 17 and 1076.

After the eulogies are finished inside the chapel, the participants make their way to the burial site. A final prayer and the 23rd Psalm is offered for the veterans honored while the groundsman places each urn in a grave already dug and marked for them. Those in attendance then take handfuls of soil and gently place some soil into each of the graves before giving them a final salute. On many weeks, Cynthia Mann, a music teacher in Summerlin plays patriotic hymns on her flute. The service is very touching and memorable. You should consider joining us at least once to see how Post 76 and other veterans groups band together for that final farewell to some of our brothers and sisters in arms.

<u>VETERAN'S EXEMPTION</u> (NRS 361.090) It applies to residents who have served in the Armed Forces of the United States in any of the following branches: Army, Navy, Marines, Air Force, Coast Guard, The National Guard, or Reserves, while on active duty, and the Merchant Marine during time of war or national emergency. A veteran must have served a minimum of 90 continuous days of active duty of which at least one day was between:

April 6, 1917 to November 11, 1918 December 7, 1941 to December 31, 1946 June 25, 1950 to May 7, 1975 September 26, 1982 to December 1, 1987 December 20, 1989 to January 31, 1990 August 2, 1990 to April 11, 1991 December 5, 1992 to March 31, 1994 November 20, 1995 to December 20, 1996

Also eligible are veterans who served on active duty in connection with carrying out the authorization granted to the President of the United States in Public Law 102-1 or served on active duty in connection with a campaign or expedition for service in which a medal has been authorized by the government of the United States. To apply for this exemption you must:

- Possess a valid Nevada Driver's License or Identification Card
- Provide the Assessor's Office with a copy of your DD214, honorable discharge paper, certificate of satisfactory service or separation documents (which indicates your date of entry and honorable discharge date).
- To determine whether a person served in connection with Public Law 102-1 as it pertains to the Gulf War or Desert Storm, or in connection with a campaign or expedition for service in which a medal has been authorized by the United States, the Assessor's Office needs ONE of the following documents in addition to the requirements above:
- A DD214 showing the dates of service and indication of connection to Desert Storm or a campaign or expedition such as an authorized Medal.
- Orders or commendations from your records that specifically indicate your duties were performed in support of the Gulf War or a campaign or expedition.
- A written statement from the military that you performed duties to support the Gulf War or a campaign or expedition. An affidavit in the form of a written, signed letter by you explaining in detail the assignments you personally performed in support of the Gulf War or a campaign or expedition.
- <u>DISABLED VETERAN'S EXEMPTION</u> (NRS 361.091) The Disabled Veteran's Exemption is provided for veterans who have a permanent service-connected disability of at least 60%. The amount of exemption is dependent upon the degree of disability incurred. To apply for the Disabled Veteran's Exemption you must:
- Possess a valid Nevada Driver's License or Identification Card
- Provide the Assessor's Office with a copy of your DD214, honorable discharge paper, certificate of satisfactory service or separation documents (which indicate your date of entry and honorable discharge date).
- Provide documentation of the percentage of permanent service-connected disability from the Veteran's Administration or from the Armed Forces of the United States.
- The benefits of this program may succeed to the surviving spouse of the disabled veteran who was eligible for the exemption at the time of death. **This requires a different form that can be obtained from the Assessor.**
- **How do I use my exemption?** The exemption amount may be applied to next year's tax bill on real property you own. this amount will be reflected on your property tax bill mailed in July of each fiscal year. It may also be applied to any personal property (which includes business personal property or manufactured housing) at any time during the year, prior to payment of taxes.
- As an option, you may choose to apply the exemption toward your Governmental Services Tax when you register your vehicle with the Department of Motor Vehicles (DMV). To use your exemption on your motor vehicle, you must obtain a DMV voucher from the Assessor's Office before you register the vehicle.
- How does the term "assessed value" relate to tax dollars? All property tax exemptions in Nevada are stated in "assessed value" amounts. The term "assessed value" approximates 35% of the taxable value of an item. The exemption amount will vary each year depending on the Consumer Price Index and the tax rates throughout the County. Let's assume an exemption after the adjusted CPI is \$1,000 assessed value and the tax rate is \$3.50 per hundred of assessed value. To determine the exemption value, multiply the \$1,000 x the tax rate .035 = \$35.00.

I, the undersigned, hereby affirm that I am a bona fide resident of the State of Nevada (possess a valid Nevada Driver's License or Identification Card), and I meet all requirements for the exemption as a veteran, and that I have not claimed this exemption in any other county in the State of Nevada.

A person must have served one of the following periods:

- a. A minimum of 90 continuous days on active duty of which at least one day was between:
- °April 6, 1917 and November 11, 1918
- °December 7, 1941 and December 31, 1946
- °June 25, 1950 and May 7, 1975

- °December 20, 1989 and January 31, 1990

The veteran must also have received, upon severance from service, an honorable discharge or certificate of satisfactory service from the Armed Forces of the United States, or who, having so served, is still serving in the Armed Forces of the United States.



Membership Year and Expired Status

Membership in The American Legion is based on a <u>calendar-year from January 1st to December 31st.</u> When a member pays their dues, they are paid up for that membership year that is specified on the renewal notice. They will also receive twelve monthly subscriptions to The American Legion Magazine.

The <u>renewal process begins in July</u> for the <u>upcoming membership year [2016]</u>. Renewal notices are sent out in July, October, January, March and May. When a member renews, they are removed from future renewal notices for that year, but often the mailings are printed long before the expected mailing month. There are times when a member pays their dues, but they still receive a renewal notice. If dues are paid to Post 76 rather than online, it takes longer for national to be notified about the renewal and the member may receive another renewal notice. If this occurs, please check with our Post 76 Adjutant to ensure we have received your dues.

If you have not paid your dues yet for 2015, you are listed as expired. Our Post depends upon membership, so please take the time to renew your membership at this time. If there is a financial reason you are unable to renew at this time, please contact the Adjutant immediately. There is be a local program that can help you out temporarily to pay your dues.
