## Service Officer's Message — VA Pension for Assisted Living or Nursing Homes

It appears that most veterans and their wives do not know about a program called the "Aid and Attendance and Housebound Improved Pension benefit" (known as A&A) This program can help defray the cost of providing care in the home. This can be paid to whoever is providing the care: wives, daughters and sons or it can be used for assisted living or nursing home.

Eligibility for this program is based the veteran being in the service for 1 day during their 90 day minimum military service during a time of war. Spouses of deceased veterans may also have some eligibility. There is also a cap on the annual income and assets.

There are at least two web sites that provide free information and assistance in filing for these benefits. The first is <u>Vet-</u> <u>eranAid.org</u> a 501©(3) charity. The second is <u>Vetangels.org</u>. These two web sites go deeper into eligibility and filing requirements.

If you require assistance in your home, assisted living or nursing home care, this may be a valuable program for you to consider. This is a benefit you have earned by your service, so it may be for you.

## The Potomac Two-Step, Youth, and Money.

# We Need Your Discharge Document !



You are VERY special! Only about 3% of living Americans have served in the military. In addition, Congressional Law (U.S.C.A. Title 36) only members during eight wartime conflicts are eligible for membership in the Legion.

An IRS new audit manual instructs auditors to have each American Legion post provide military service records or discharge papers for each active member during their assessments of the Legion's tax-exempt status. The IRS fined posts that didn't comply. American Legion Post 447 in Round Rock, Texas, was fined \$12,000 for "a lack of compliance" towards the IRS' request. Post 447 had submitted documentation the IRS asked for, but apparently it wasn't to the agency's satisfaction. The post was fined \$1,000 per day until the IRS received enough documents to satisfy their request.

"As former military members, the one thing we know how to do is follow regulations," said Louis Celli, national legislative director for the American Legion. "The inspection manual they give to inspectors tells them to look for documents that we were not told to maintain in the first place." Celli elaborated that the IRS' problem is that previously the

IRS stated that organizations must maintain records of members and their dates of service, but not their official discharge papers. That has now apparently changed.

We were instructed a number of years ago, that discharge papers contained sensitive information that we should not have, so we shredded the paperwork we did have on file. Now, because of the new IRS effort to target non-profit organizations like us, we need to ask you to again provide a copy of your discharge papers to us in case we get audited. The information that we should not have, and do not need is your place of birth and social security number. Please cross out those items, if they exist. Discharge papers can be of many forms, commonly a DD214, but some do not have either of those bits of data, so don't worry if yours does not. If you do not have a copy, there are many ways that you can get your DD214 or discharge documents. Discharge documents are stored at the National Archives and Records Ad-

ministration's National Personnel Records Center, Military Personnel Records, St. Louis, Missouri. The records are free to you, so do not pay anyone a fee. The easiest is to go online at *http://www.archives.gov/veterans/ military-service-records/*. You can then apply online directly, or print out a SF-180 to send or fax in. If you do not have access to the internet, you can write a letter with the following information to them.

Include as much of the following information as possible: (1) The veteran's complete name used while in service, (2) Service number or social security number, (3) Branch of service, and (4) Dates of service. Date and place of birth may also be helpful, especially if the service number is not known.

## NOW GET A COPY TO POST 76.

If you have it in your possession already, or get a copy from the records center, make a copy, mark out social security number and place of birth, if that information is on the form, and get it to us any of four different ways.

(1) Scan it and attach to an email to us at:



(4) Bring your document along to a meeting and hand deliver it to the Adjutant or any other officer.
