From The Commander

We have included two important documents in this Newsletter. The first is your application for FREE insurance courtesy of the American Legion. All you have to do is fill out the form and mail it in. This will give you \$1,000.00 FREE accidental insurance and \$5,000.00 accidental death if you are traveling on official Legion business.

The second form is really more important and will affect each and every Veteran. Burial Flags will no longer be available to our next of kin or friends at the time of our funerals. The V.A. will no longer make the Flags available by sending them to funeral homes or cemeteries. The only way your family or friend can have a flag for your funeral is by instructing them to fill out the form which is in the Newsletter. The form will have to be signed by Postmaster. If there is a Flag depot in Las Vegas, you will be instructed to go there and one will be given. If not, one will be mailed to the address of the deceased in 2-5 days. Only one flag per social security number, per address. If the flag is lost, stolen or damaged. There will be no replacement from the V.A.

It is important to fill out the form, tell someone about it, and keep it with your, Paper Safe, or other personal papers. This is not a new law, just an updated interpretation of the existing policy.

If you are a WW II Veteran and/or a Pearl Harbor Survivor, please contact the Commander.

Wreaths Across America

Members of Post 76 come out every year to place wreaths on graves during Wreaths Across America.

Our own Mrs. Veteran Global Nation Pranava Moody, a member of Post76, spoke at the service. She talked about her work with the military, her time supporting veterans and her disability at a Wreaths Across America ceremony at the Veterans Memorial Cemetery in Boulder City on Saturday December 13, 2014. When



she stood at a lectern before the hundreds in attendance, the 36-year-old teared up before even saying a word.

"It's really important to look back and think about those who helped pave the road for our freedoms," Moody said, reflecting on her personal feelings and one of the goals of the wreaths program.

Commander Forman, who served in the U.S. Army during the Vietnam War, said although the event marks a solemn day, it's an honor for him to recognize those who fought and died to protect America's freedoms.

Trustee Jagemann said. "We both had friends who didn't come back (from Vietnam), and had a lot of friends we've lost since, so we're happy to be alive and happy to come do whatever we can do to help out."

No Veteran Alone

Each Thursday morning, members of Post 76 led by Commander Forman, make their way to the Veterans Memorial Cemetery in Boulder City to attend services for veterans being buried without family or friends to attend their funeral. Along with the Patriot Guard who stand flag lines along with many others from veterans organizations, or just grateful citizens, who give of their time to attend and honor those who served and are now entering the Post Everlasting.



According to Gregory Hall, Commander of Post 31 in Boulder City, once a veteran dies, the county does a records search for next of kin. If there isn't a next of kin available, the veteran is cremated and the state veterans cemetery takes care of the funeral service. Identifying the deceased can take several months, he said. Still, they all believe that every veteran should be buried with honor.

"It just feels like the right thing to do. It's sad that they have nobody," said Bobbi Oates, member of Post 76, and representing the Women Veterans of Nevada. "We have to take care of our veterans and give the example so that others will take care of us as we go along." The services are provided on alternating months by the Women Veterans of Nevada and the Vietnam Veterans of America Chapters 17 and 1076.

After the eulogies are finished inside the chapel, the participants make their way to the burial site. A final prayer, the 23rd Psalm, for the veterans honored while the groundsman places each urn in a grave already dug and marked for them.

Shortly after, those in attendance take handfuls of soil and gently place some soil into each of the graves before giving them a final salute.

1. Your Post uses the US Postal Service, email, and telephone to reach out to you and keep you current on Post 76 activities and veterans' affairs. There are many members

for whom we have incomplete information, and we're making an effort to update the database we have for all our members. If you receive a request from us to provide or verify information (address, email, or phone number), then you can help us stay in touch with you by supplying the contact details.

- 2. As you know by now, the Internal Revenue Service (IRS) demands that American Legion Posts have available, if the Post is audited, any members' military service discharge documents, Form DD214 or its equivalent. This is a requirement for our tax-exempt status with the IRS. Every new member, or transfer from another Post, must now show the Adjutant his/her discharge papers before becoming a member of Post 76. We also are making an effort to get copies of discharge papers from all current members of Post 76, and many of you have helped us by sending us your documents. If you have not sent us a copy of your discharge documents, PLEASE help us keep the IRS happy and forward a copy of your discharge papers to Post 76 by (1) attaching it to an email and sending to nvpost76@gmail.com; (2) sending via USPS mail to: NV Post 76, P.O. Box 34012, Las Vegas, NV 89133-4012; or (3) bringing your document along to a meeting and hand deliver it to the Adjutant or any other officer. If you have a question on whether or not you have forwarded a copy, please call the Adjutant, Stephen Daugherty, at 253-691-0617 for any assistance you need to move this important task along.

Do you serve on committees, to this there is no trick, or leave the work to just a few, and talk about the clique?


Please come to meetings often and help with hand and heart, don't just be a member, take an active part.

Membership Year and Expired Status

Membership in The American Legion is based on a *calendar-year from January 1st to December 31st.* When a member pays their dues, they are paid up for that membership year that is specified on the renewal notice. They will also receive twelve monthly subscriptions to The American Legion Magazine.

The renewal process begins in July for the <u>upcoming membership year</u>. Renewal notices are sent out in July, October, January, March and May. When a member renews, they are removed from future renewal notices for that year. There are times when a member pays their dues, but they still receive a renewal notice. If dues are paid to Post 76 rather than online, it takes longer for national to be notified about the renewal and the member may receive another renewal notice. If this occurs, please check with our Post 76 Adjutant to ensure we have received your dues.

If you have not paid your dues yet for 2015, you are listed as expired. Our Post depends upon membership, so please take the time to renew your membership at this time. If there is a financial reason you are unable to renew at this time, please contact the Adjutant immediately. There is be a local program that can help you out temporarily to pay your dues.

INSTRUCTIONS

A. How can I contact VA if I have questions?

If you have questions about this form, how to fill it out, or about benefits, contact your nearest VA regional office. You can locate the address of the nearest regional office in your telephone book blue pages under "United States Government, Veterans" or call 1-800-827-1000 (Hearing Impaired TDD line 1-800-829-4833). You may also contact VA by Internet at https://iris.va.gov/.

B. How do I apply for a burial flag?

Complete VA Form 27-2008, and submit it to a funeral director or a representative of the veteran or other organization having charge of the funeral arrangements or acting in the interest of the veteran. You may get a flag at any VA regional office or U.S. Post Office. When burial is in a national, State or military post cemetery, a burial flag will be provided.

C. Who is eligible for a burial flag?

Generally, veterans with an other than dishonorable discharge. *Note:* This includes veterans who served in the Philippine military forces while such forces were in the service of the U.S. armed forces under the President's Order of July 26, 1941 and died on or after April 25, 1951, and veterans who served in the Philippine military services are eligible for burial in a national cemetery.

Veterans who were entitled to retired pay for service in the reserves, or would have been entitled to such pay but not for being under 60 years of age.

Members or former members of the Selected Reserve (Army, Air Force, Coast Guard, Marine Corps, or Naval Reserve; Air National Guard; or Army National Guard) who served at least one enlistment or, in the case of an officer, the period of initial obligation, or were discharged for disability incurred or aggravated in line of duty, or died while a member of the Selected Reserve.

D. Who is not eligible for a burial flag?

Veterans who received a dishonorable discharge.

Members of the Selected Reserve whose last discharge from service was under conditions less favorable than honorable.

Peacetime veterans who were discharged before June 27, 1950 and did not serve at least one complete enlistment or incur or aggravate a disability in the line of duty.

Veterans who were convicted of a Federal capital crime and sentenced to death or life imprisonment, or were convicted of a State capital crime and sentenced to death or life imprisonment without parole, or were found to have committed a Federal or State capital crime but were not convicted by reason of not being available for trial due to death or flight to avoid prosecution.

Discharged or rejected draftees, or members of the National Guard, who reported to camp in answer to the President's call for World War I service but who, when medically examined, were not finally accepted for military service.

D. Who is not eligible for a burial flag? (Continued)

Persons who were discharged from World War I service prior to November 12, 1918, on their own application or solicitation by reason of being an alien, or any veterans discharged for alienage during a period of hostilities.

Persons who served with any of the forces allied with the United States in any war, even though United States citizens, if they did not serve with the United States armed forces.

Persons inducted for training and service who, before entering such training and service were transferred to the Enlisted Reserve Corps and given a furlough.

Former temporary members of the United States Coast Guard Reserve.

E. What documentation is required in order to receive a burial flag?

Provide a copy of the veteran's discharge documents that shows service dates and the character of service, such as DD Form 214, or verification of service from the veteran's service department or VA. Various information requested, is considered essential to the proper processing of the application. Ensure these areas are completed as fully as possible. Note: If the claimant is unable to provide documentary proof, a flag may be issued when a statement is made by a person of established character and reputation that he/she personally knows the deceased to have been a veteran who meets the eligibility criteria.

F. Who is eligible to receive a burial flag?

Only one flag may be issued for each deceased veteran. Generally, the flag is given to the next-of-kin as a keepsake after its use during the funeral service. The flag is given to the following person(s) in the order of precedence listed:

surviving spouse

children, according to age

parents, including adoptive, stepparents, and foster parents

brothers or sisters, including brothers or sisters of half blood


uncles or aunts

nephews or nieces

others, such as cousins or grandparents

When there is no next-of-kin, VA will furnish the flag to a friend making a request for it. If there is no living relative or one cannot be located, and no friend requests the flag, it must be returned to the nearest VA facility.

Note: The flag cannot be replaced if it is lost, destroyed, or stolen. Additionally, a flag may not be issued after burial unless it was impossible to obtain a flag in time to drape the casket or accompany the urn before burial. If the next-of-kin or friend is requesting the flag after the veteran's burial, he or she must personally sign the application and explain in Item 15 "Remarks" the reason that prevented timely application for a burial flag.
