### The Surprise Effect


### Your Post 76 Serving Our Local Area This Past Quarter

### "The Spirit of Freedom" Color Guard



### **Veterans Day Parade**



Post 76 proudly marched the Las Vegas Veterans Day Parade on November 11, 2014 accompanied by 4 Model T Fords driven by members of the Las Vegas Model T Club. The Las Vegas Veterans Day Parade is the second largest parade in the nation – second only to New York. While Las Vegas is known for many attributes including the title of the Entertainment Capital of the World, most people don't know that every major veterans organization in southern Nevada participates in the annual Veterans' Day Parade. The parade includes all the schools with JROTC units, congressionally recognized organizations, civic and commercial entities. Veterans' organizations from the surrounding states (California, Arizona and Utah) have regularly participated in the Las Vegas Veterans' Day Parade.

### **Recruiting ALL Fellow Veterans**

This is from a post on the "MyLegion" electronic Adjutants forum.

The question was "Why the proposal to extend membership to any US military veteran was not considered at the convention and pulled from consideration". The answer was:

There is already a congressionally chartered organization that accepts all who honorable served - AMVETS. Because of that there is zero chance of changing Legion dates since it unnecessary and would require putting AMVETS out of business.

From the AMVETS website, "On July 27, 1947, President Harry S. Truman signed Public Law 216, making AMVETS the first World War II organization to be chartered by Congress. Since then, the original charter has been amended several times to admit as members those who served in different eras. Today, membership in AMVETS is open to anyone who is currently serving, or who has honorably served, in the U.S. Armed Forces from World War II to the present, to include the National Guard and Reserves."

What does this mean for Post 76 members? When you run across someone who is a veteran, tell them about the American Legion and your Post, but not if they are not in our eligibility periods [see application on back page], you should tell them about AMVETS. Every service person should belong to some organization that looks out for them and our current military and their families. While there are not any AMVETS Posts yet in Nevada, it does not mean they can't join AMVETS and add to the clout in Congress. There are so few veterans [1 in 14] compared to the total population, that we need all the representation by multiple organizations in Washington, DC. as possible.

### Adjutant's Pen



Legion members need to be alert for multiple dues invoice mailings from our Headquarters. There is a time delay from when you renew your membership online or by mail and when you actually get your renewal logged at Headquarters; so you may receive another dues invoice, even though you know you've paid. All Legionnaires who have renewed their membership with Post 76 receive a Welcome Letter from the Post 76 Commander along with their new membership card. Then you know you can ignore any subsequent dues invoices. If you have any questions about your membership status, you can call the Adjutant, Stephen Daugherty, at (253) 691-0617 any time 24/7.

On another familiar subject, we have received many member service discharge papers (usually DD214) and thank you for helping us stay ahead of the IRS; the discharge document is a requirement from the IRS for all American Legion posts to keep their tax-exempt status. If you haven't already, please try to forward a copy of your discharge papers to Post 76 by (1) attaching it to an email and sending to NVPost76@gmail.com; (2) sending via USPS mail to: NV Post 76, P.O. Box 34012, Las Vegas, NV 89133-4012; or (3) bringing your document along to a meeting and hand deliver it to the Adjutant or any other officer. If you need to get a new copy, you can apply online at http://www.archives.gov/veterans/ military-service-records/. It's a free service, so don't get involved with a 3rd party website and pay for the services.
